Principal's Report: Kort Goodman

Funding for Murphy building was not approved with the capital funding applications, needs to be knocked down as per the advice from the Diocese, therefore the college will need to self-fund. 26 applications and 11 got approved. We need the classrooms until the new classrooms can be built, so it's a catch 22. School fees funding model will be going to board to be looked at, for example everyone is paying the same regardless of subjects/camps etc., creates equity issues. Strategic plan - 2/3 of the staff have been met with to see why SJC exists (purpose) and where it will be in 4-8 years. Parents/community still need consultation.

Covid – teachers have been told to prepare for the second wave. Half a dozen students are now on managed timetables and studying from home 1-2 days a week after the remote learning worked better for them. 7% of kids struggled with remote learning on top of those that are normally disengaged. Need to get better at subject selection, aspirational dreams etc. needs to start early in years 7 and 8 to get a get set plan in place. Curriculum is being reviewed. Staffing issues high turnover, teacher shortages is across the board. P and F to do a once off staff lunch to show our support and gratitude for their hard work and uncertainty. (100 staff). ATAR is stressing a lot of teachers. Wellbeing hub which all teachers have access too, including 4 counsellor visits, plus access to senior leaders. Cancellation of Europe trip has been massive for stress, anxiety and disappointment.
