- Optional: International tours, public performances, valedictory dinner, inauguration ball, senior jersey

### Payment Options

The College fee structure and budget relies on the prompt payment of fees. Our preferred payment options are:

- Direct Debit payment schedule • Credit Card payment schedule • BPAY • Qkr by Mastercard

Fees are billed at the commencement of each Term (4 times per year); February, April, July & October. Invoices and statements are emailed. It is important that the current email address is on file.

### Discounts

Families with more than one child will always be invoiced at the full rate, with family discounts applied thereafter. Further Diocese discounts are offered on application for siblings in Year 7-12 at St Saviour's, Mary Mackillop & St Mary's Colleges.
